


#### 1. UPDATE What have the commissioners meddled with

The Commissioners are in a desperate hurry to change the look and feel of Tauranga and will leave behind an enormous rate burden to pay the cost of their grandiose ideas. Every week there are new proposals to spend more money. Staffing numbers are exploding.

#### LATEST for downtown Tauranga. Summary by Barry Scott.

"TCC intends to sell the land under the new downtown civic redevelopment to a yet to be created CCO (Council Controlled Organisation) for \$1 – ie make a gift of it, in other words - and then lease it back at a peppercorn rental.

The proposal says that the CCO would own the land and be jointly governed by the Council and the Otamataha Trust (OT). Creating a new CCO, which will be gifted a large block of downtown (sold for \$1) and then leased back to the TCC. The city will lose control of this land.

TCCs' proposal is an attempt to solve a problem that in the opinion of a large majority of Tauranga's residents and ratepayers isn't our city's problem. The commissioners, are appointees of the Minister and central government, not elected representatives of the citizens of our city, and whilst they may be concerned to grant a form of compensation that will satisfy OT's demands, they do not have the right to do that by giving away valuable Tauranga city assets - assets that belong to our residents and ratepayers, not central government. If the commissioners and central government see OT's demands as being a serious problem that must be satisfied or made to go away, let central government do that from its own funds and resources. Don't touch our city's assets!"



TWO WEEK publication consultation !!!!

#### What the commissioners should be meddling with

Remove the clog points of our roading system – Turret Rd bridge, Maungatapu bridge. Hewletts Rd, reopen Links Ave, Greerton mess.	
Improve the traffic management of our roading network. Stop the anti-car attitude of the TCC Transport Section.	
Solved the downtown carpark building structural problem, not just sold the building and land.	\$30 million wasted
Build the cycleways Tauranga needs, not just talk about it.	
Architectural competition for downtown redevelopment, get a solution we will be proud of.	
Develop Tsunami escape routes, Improving public parks, community facilities. Commissioners are anti sirens regardless of the survey results.	
More community facilities halls, parks, amenities	
Consulting with the Ratepayers and putting coherent plans out for debate months ahead of the decision dates.	
Stop being Commissars.	



Glen Crowther from Sustainable BOP Trust recently shared his thoughts with us about Tauranga City Council's current approach to community engagement:

"If TCC wants to get better engagement with local people, it won't happen by rushing through strategies and plans without time to consult properly, and then imposing the results on residents.

The best and most cost-effective option is to collaborate with a wide range of community organisations, starting with resident groups and key city-wide networks, and steadily work things through, issue by issue, consultation by consultation, allowing at least one month for submissions and 10 minutes for each oral submission. "



# **Final Thoughts**

Last thoughts from emails I received today

"Councils now tell us they know what we need and want. And that they know better than the community. And really, basically, local democracy is a waste of time. The wrong people participate."

"Consultation is window dressing for decisions already taken. Engagement is another process but it means elected officials and unelected bureaucrats prepared to hear, see, believe and respect the people they govern."

Next Tauranga City elections are scheduled for July 2024. Nearly 5 years of Commissioner rule.




## Tsunami/ All Hazard Sirens


